#### **MEMBERSHIP BENEFITS**

Membership with Prana Divine Healing Sanctuary grants access to the Association's ministerial offerings, including Energy Enhancement System sessions, other healing modalities and technologies, classes, workshops, community events, and educational resources designed to support spiritual and physical well-being. Participation in any offering is voluntary, and members may choose the activities that resonate with their personal path. All offerings are spiritual and educational in nature and do not constitute medical treatment or advice. Members are personally responsibility for their health, to research modalities of interest, and make informed decisions for their own bodies and lives.

# 1. Purpose and Protections

This Association of Members declares that our purpose is to provide a sacred and protected platform for ministry, healing, education, and spiritual fellowship among its Members. The Association exists to facilitate ministerial, educational, and faith-based services, activities, and community exchanges between Members in the private domain, under the protections guaranteed by the Universal Declaration of Human Rights (UDHR), the Constitution of the United States of America, and all corresponding provisions within State Constitutions.

Within this protected space, Members may also offer or receive goods, services, or creative works through voluntary donation or trade in support of one another and the community as part of the Association's ministerial mission. All activities, offerings, and exchanges within the Association are conducted privately, by and between Members, for spiritual, educational, and community purposes in alignment with Divine law and the inherent rights granted by our Creator.

## 2. Foundational Rights and Freedoms

We believe that the Holy Scriptures, the Universal Declaration of Human Rights (UDHR), the Constitution of the United States of America, and the various Constitutions of the several States of the Union guarantee our Members the rights of absolute freedom of religion, free speech, petition, assembly, and the right to gather together for the lawful purpose of helping one another in asserting our rights protected by those Constitutions, Bill, and Statutes, in addition to the rights to be free from unreasonable search and seizure, the right to not incriminate ourselves, and the right to freely exercise all other unalienable rights as granted by our Creator, our Almighty God and guaranteed by those Constitutions, Bill, and Statutes.

#### 3. Private Domain and Freedom of Association

WE HEREBY Declare that we are exercising our right of "freedom of association" as guaranteed by the Universal Declaration of Human Rights (UDHR), the Constitution of the United States of America and equivalent provisions of the various State Constitutions. This means that our Association activities are restricted to the private domain only and outside of the jurisdiction of government entities, agencies, officers, agents, contractors, and other representatives as provided by law.

# 4. Member Autonomy in Seeking Counsel

We declare the basic right of all of our Members to decide for themselves which Association Members could be expected to give wise counsel and advice concerning all matters including, but not limited to, physical, spiritual, and mental health care assistance, law, and any other matter and to accept from those Members any and all counsel, advice, tips, who we feel are able to properly advise and assist us.

## 5. Choice of Therapies and Assistance

We honor the inherent freedom of each Member to explore, experience, and practice the forms of healing, education, and spiritual development that best support their personal growth and wellbeing. Each Member retains the right to seek and participate in the modalities, teachings, and activities that resonate with their own discernment, for the purpose of achieving balance, wellness, and connection with the Divine. The Association provides a private environment in which such exploration and exchange may take place freely, among Members, without interference from outside authorities or commercial oversight.

# 6. Membership Recognition and Member Rights

The Association will recognize any person(s), natural or otherwise (irrespective of race, color, or religion), who have joined this Association or any social media group organized, created, or managed by this Association and is in agreement with these principles and policies as a Member of this Association, providing said person has not been sanctioned, exercised, or otherwise banned by the association, and will provide a medium through which its individual Members may associate for actuating and bringing to fruition the purposes heretofore declared.

Members are granted the right to understand the nature of any Association offerings before participating; to request access to the Association's Bylaws; and to have personal information kept private within the Association. Any complaint must be submitted in writing within three months of the incident to the Association's designated person, committee, or tribunal for private resolution.

## 7. Membership Conduct, Termination, and Withdrawal

Membership to this Association, "Prana Divine Healing Sanctuary", and any of its groups may be terminated by the association Trustees or their designee, at any time, should they conclude that a specific Member is interacting with them or any other Members in a way that is contrary or detrimental to the focus, principles, and betterment of this Association. A Member may also withdraw from this Agreement and terminate membership in writing at any time.

#### 8. Jurisdiction and Internal Grievances

I understand that, since the Association is protected by the First and Fourteenth Amendments to the Constitution of the United States of America, it is outside the jurisdiction and authority of Federal and State Agencies and Authorities concerning any and all complaints or grievances against the Association Members or other staff persons. All rights of complaints or grievances will be settled privately within the Association by a designated designee, committee, or tribunal and will be waived by the Member for the benefit of The Association and its Members. By agreeing to this membership

form, I affirm that I have sought sufficient education to determine that this is the course of action I wish to take for myself.

# 9. Membership Covenant, Capacity, and Informed Consent

I agree to join Prana Divine Healing Sanctuary, a Private Ministerial Association under common law, whose Members seek to help each other achieve improved spiritual health, better physical health, and good quality of life:

I am voluntarily changing my capacity from that of a public person to that of a Private Member. My activities within The Association are a private contractual matter that I refuse to share with the Local, State, or Federal investigative or Enforcement agencies. I fully agree not to pursue any course of legal action against a fellow Member of The Association, unless that Member has exposed me to a clear and present danger of substantive evil, and upon the recommendation and approval of the Association.

Informed consent in this Association means that I understand the private, ministerial, spiritual, and educational nature of all offerings; that no medical diagnosis, treatment, or prescription is being provided; and that I am choosing to participate voluntarily, based on my own research and discernment about what is appropriate for my body and life.

I understand that members, facilitators, teachers, and service providers within the Association may or may not be licensed professionals. My membership creates a private contractual, member-to-member relationship. I waive any HIPAA or similar statutory privacy complaint processes with respect to records maintained within the Association. Records will remain strictly confidential and released only upon my written request. I further agree not to hold the Association or its members financially liable for outcomes of services, education, or healing practices I choose to participate in.

# 10. Assumption of Risk, Release of Liability, and Indemnification

- **(a) Assumption of Risk:** I understand and agree that participation in any and all activities, classes, workshops, exercises, services, or use of any equipment, healing, wellness, or health-related technology offered through Prana Divine Healing Sanctuary or Satya Aligned Prana Divine Private Ministerial Association is completely voluntary and undertaken at my own risk.
- **(b) No Medical Claims:** The Association, its facilitators, ministers, trustees, officers, employees, or other members make no medical, therapeutic, or outcome-based claims of any kind.
- **(c) Personal Responsibility:** I assume full responsibility for my wellbeing and any outcomes resulting from participation in any service, session, activity, or use of equipment. I am encouraged and expected to take personal responsibility for my own health and safety, to research and understand my own body and conditions, and to make my own informed decisions regarding participation in any activity or modality offered within the Association.
- **(d) Indemnification and Hold Harmless:** I agree to hold harmless, indemnify, and defend the Association, its trustees, facilitators, officers, and members from any and all liability, damages, losses, claims, or causes of action that may arise from my participation in any Association activity or service.

**(e) Minors, Family Members, and Animals:** I acknowledge and agree that this waiver and assumption of risk extends to my children, dependents, family members, guests, and any animals I bring onto Association property or include in Association activities. I accept full responsibility for their safety, supervision, and conduct during participation in or presence at any Association event, service, or session. I further agree to hold harmless and indemnify the Association, its trustees, facilitators, and members from any and all liability or claims that may arise from their participation or presence.

# 11. Final Agreement and Waiver Acknowledgement

By signing below, I acknowledge and affirm that I have entered into membership with Prana Divine Healing Sanctuary, a ministry of Satya Aligned Prana Divine Private Ministerial Association, as a private, faith-based relationship founded on mutual respect, spiritual alignment, and voluntary participation.

I understand and agree that all activities, offerings, and exchanges within the Association occur in the private domain and are not subject to external regulation or public jurisdiction. I have freely chosen to participate, and I recognize that all services and activities are offered as spiritual, educational, or ministerial expressions.

I enter into this Agreement of my own free will, without any pressure or coercion. I affirm that I do not represent any Local, State, or Federal agency whose purpose is to regulate or approve products or services, or to carry out any mission of enforcement, entrapment, or investigation. I have read and understood this document, and my questions have been answered to my satisfaction. I understand that I can withdraw from this Agreement and terminate my membership in this Association at any time, and that my membership can and will be revoked if I engage in abusive, violent, menacing, destructive, or harassing behavior toward any other Member of the Association.

I further acknowledge that I have read, understood, and agreed to the waiver, assumption of risk, and indemnification provisions contained in this Agreement, and I release the Association, its trustees, facilitators, ministers, and Members from any and all liability arising from my voluntary participation in its activities.

This Agreement and waiver apply to me, my family members, dependents, and any animals I bring onto Association property or involve in Association activities.
